Destinations Credit Union will confirm receipt of your forms on the next business day after it is received by mail or upon delivery by the person accepting your materials. Your receipt confirmation ensures that your materials were received. An incomplete application for nomination will not be considered. Credit Union staff may not assist in the preparation of Board Nomination documents.

**NEXT STEPS IN THE BOARD ELECTION PROCESS**

All Board Candidate application forms will be forwarded to the Nominating Committee Chairperson. The Nominating Committee will decide upon those qualified applicants to be placed in nomination for a seat on the Destinations Credit Union Board at least 60 days prior to the Annual Meeting. The Nominating Committee will inform you directly of its decision concerning your application. If you are qualified to run for the Board but the Nominating Committee does not place your name in nomination, you may still run for a seat on the Destinations Credit Union Board by petition process.

## BOARD QUALIFICATIONS

---

*Candidates for board of directors' elections are considered without regard to race, color, religion, sex, national origin, age, marital or veteran status, or in the presence of a non-related medical condition or handicap.*

The following qualifications outline board eligibility requirements:

The **Maryland Code** [§6-325b.] requires that each director:

- (1) Shall be a member of the credit union;
- (2) Shall be bonded;
- (3) May not have:
  - Defaulted on the payment of any monetary obligation to the credit union;
  - Been convicted of any criminal offense involving dishonesty or breach of trust;
  - Habitually neglected to pay debts;
  - Become insolvent or bankrupt; or
  - Been removed by any state or federal regulatory agency from office as an officer, official, or employee of a financial institution; and
- (4) Shall comply with any other qualifications set forth in the credit union bylaws.

The **Nominating Committee** of Destinations Credit Union requires a director to be:

- (1) At least 18 years of age.
- (2) A member in good standing of Destinations Credit Union for at least two (2) years.
- (3) An individual with either financial or legal background or related experience – or with at least two years' service on a Destinations Credit Union Committee by the time of the Annual Meeting.

A Destinations Credit Union employee will be eligible to become a candidate only after two years has passed since he or she has left the employment of the Credit Union.

All Directors and Committee Members are required to sign and comply with the following **Agreement/Education Plan** for their service on the Destinations Credit Union Board:

### **Destinations Credit Union Board of Directors Agreement/Education Plan:**

- Attend a minimum of nine monthly board meetings and not miss more than two consecutive meetings per year.
- Participate fully in the determination of policies, monitor financial performance, give full attention to problems affecting the credit union, and vote on all issues proposed for board action. Ensure that any and all action taken is within the guidelines and regulations set forth by the Department of Financial Regulation and the National Credit Union Administration.
- Remember that the business of the credit union and its individual members is confidential.
- Render assistance whenever possible or requested to fellow board members, management, and employees of the credit union in the performance of their duties.
- Should any conflict or perceived conflict of interest arise, I will disclose such to the board immediately and refrain from voting on any issue related to such conflict. This includes involvement with any individual, group, or organization that may create such conflict with the credit union.
- Attend Destinations CU's annual planning session unless prevented by circumstance beyond my control.
- Increase and strengthen my knowledge of the credit union organization and its services, as well as my responsibility as a board member, by attending or completing at least one training program per year.
